ALBANY, NY, 08/01/22 —Philmont Beautification, Inc. (PBI) is one of this year's <u>Preserve New York</u> (PNY) grantees. **Their grant of \$14,000** will enable PBI to hire Jessie Ravage of Cooperstown to complete a potential State and National Register nomination of the Village of Philmont Historic District for over 400 resources and properties. This designation could ultimately benefit the work of PBI, residents and business owners by allowing them to use the Federal and NYS Historic Tax Credits for rehabilitation projects. The Preservation League of NYS and their program partners at the New York State Council on the Arts (NYSCA) and the Robert David Lion Gardiner Foundation are thrilled to help fund this important work.

"This grant award will enable the community and the Village of Philmont to evaluate and advance the creation of the Village of Philmont Historic District" said **John Gourlay, President, Philmont Beautification, Inc.** "PBI is delighted to have been chosen for this grant award that will assist with hiring the consultant, Jessie Ravage, to conduct this State and National Register nomination with the participation of PBI and the community-based Heritage Working Group."

A prior PNY grant award to PBI supported preparation of a <u>cultural resource survey</u> in the Village of Philmont. It reviewed 425 properties. The CRS, completed in January 2021, resulted in a <u>Resource Evaluation</u> by NYS SHPO determining a National Register-eligible historic district encompassing nearly all of the village's historic infrastructure.

The Village of Philmont developed around a power canal that ran a number of woolen and paper mills when George P. Philip began the "most ambitious waterpower development in Columbia County" in 1845 on what became known as "Factory Hill." (Peter Scott. *Looking for Work: Industrial Archeology in Columbia County, New York.* Columbia County Historical Society). Philmont retains a variety of residential architecture—both in taste and scale—representative of the period of development from the mid-1840s through the second quarter of the 1900s. Churches, an opera house, hotels and taverns, mill worker row houses, and commercial buildings form a coherent historic streetscape.

At its 2022 meeting, an independent grant panel selected **22 applicants in 18 counties to receive support totaling \$235,920**. Each grant supports important arts and cultural initiatives, as well as

economic development related to our state's arts and cultural heritage. Many of these grants will lead to historic district designation or expansion, telling the stories of communities throughout the state and allowing property owners to take advantage of the New York State and Federal Historic Tax Credits. This is even more valuable now, with the NYS Commercial Historic Tax Credit recently expanded for small projects, granting property owners a 30% credit. With the announcement of the 2022 awards, support provided by Preserve New York since its launch in 1993 totals more than \$3.5 million to 510 projects statewide.

The Preserve New York program is a regrant partnership between the New York State Council on the Arts (NYSCA) and the Preservation League, made possible with the support of the Office of the Governor and the New York State Legislature. The Robert David Lion Gardiner Foundation has generously provided additional funds to support nonprofit projects in Nassau and Suffolk Counties.

Since 1993, Preserve New York has been providing funds to municipalities and nonprofit organizations that need technical, professional assistance to guide a variety of preservation projects. The historic structure reports, building condition reports, cultural landscape reports, and cultural resource surveys funded through this program lead to positive outcomes across New York's 62 counties.
